Each team will comprise:

Teams should consist of a minimum of two junior riders and can have a maximum of two young riders. Parameters defined as follow:

DEFINITION OF A YOUNG RIDER

A person may compete as a Young Rider from the beginning of the calendar year in which he reaches the age of sixteen (16) until the end of the calendar year in which he reaches the age of twenty one (21).

DEFINITION OF A JUNIOR

A person may compete as a Junior from the beginning of the calendar year in which he reaches the age of fourteen (14) until the end of the year in which he reaches the age of eighteen (18).

Each country that don't have a Team, can compete with one or two individual riders.

Other committee members: 1 team leader, 1 trainer, 1 handler, 1 driver (per country)

Accommodation will be of the responsibility of each nation.

7. FACILITIES

7.1. Committees

The organising committee is not responsible for providing food.

7.2. Horses

Free accommodation, for all horses, in identical covered boxes measuring 3 x 3 m, close to the

competition zone (Dressage and Maneability Tests) for the whole of the championship.

Supply of straw or shavings for beds and hay for horses up to a limit of 3 bales of shavings or 5

bales of straw and 2 bales of hay per horse.

Concentrated rations are not supplied.

Each committee shall be provided with a total of 4 horse boxes plus an additional box for use as

a harness room.

7.2.1. Straw, Hay and Shavings

straw, hay and shavings.

9. VETERINARY REGULATIONS

Horses must have an Equine Identification Document issued by their countries of origin, in conformity with European legislation.

EQUINE INFLUENZA VACCINATION

All horses taking part must be vaccinated as per the FEP Vet. Regs.

10. OTHER DISPOSITIONS

10.1 Complaints

In conformity with the International Working Equitation Regulations. Complaints must be submitted in writing (in English) and addressed to the President of the Jury together with a € 150 (one hundred fifty euros) deposit.

The deposit shall only be returned if the complaint is upheld.

10.2. Opening and Closing Ceremonies. Prize-giving Ceremony.

Closing Ceremony Idem

The prize-giving ceremony for the award of trophies and ribbons for each of the trials shall take place at the end of each trial, in which the top three in each trial should enter the arena on horseback.

Competitors are requested to comply with the organisers' instructions and collaborate with the organisers for the successful completion of the above.

10.3. Insurance

All owners and competitors are personally responsible for the damages caused to third parties, by themselves, employees, agents or horses and they are accordingly most strongly advised to take out civil liability insurance, fully covering their participation in trials in their own country or abroad and that such insurance policy must be kept up-to-date.

The organising committee cannot be held responsible by third parties if a competitor does not have a valid insurance policy.

Horses and competitors' material shall remain under their sole custodianship during the competition.

Competitors are responsible for all repatriation costs resulting from accidents.

The organising committee and officials are not responsible for any material or bodily damages caused by accidents with competitors, horses, owners or employees, including damages to vehicles, trailers, materials or other objects.

As a consequence of the above sub-paragraph, competitors forthwith forfeit their right to any legal redress against the organising committee.

All participants must ensure that that their personal civil liability, individual accidents and medical insurance policies, etc. are valid for the period of the performance of their activity.

The organisation can never be responsible or held liable if such agreements have expired. The participants are, on the other hand, also responsible for their horses and materials for the period of the competition as a whole.

They are also responsible for the payment of the expenses incurred on the return journey in the event of any accident.

A horse's owner or rider is the only person liability for damages caused to third parties by him/her, employees, assistants as well as the actual horse.

10.4. Liability

The organising committee and commissioners are not liable for material, bodily and any other damages that may eventually occur, caused by accidents with the competitor, horse and handlers.

The organising committee and commissioners are not liable for damages to cars, harnesses, accessories or other objects, theft or loss, fire and other accidents.

10.5 Programme Alterations

In exceptional cases and subject to the approval of team leaders and jury, the organising committee reserves the right to make changes to the programme for the purpose of resolving any problem or errors deriving from omissions or owing to unforeseeable circumstances. Information on such alterations should also be supplied to all competitors, team leaders and officials as soon as possible.

The said alterations do not include the general championship regulations.

10.6. Right of Entry

The organising committee shall provide the committees and horse owners with the necessary access cards for the trial enclosure.

Access to the box zone is restricted exclusively to committees, horse owners, commissioners and organisation staff. Commissioners or security personnel may, therefore, request the identification of any participant in the competition, at any time.

SECURITY

1. ACCESS TO BOX ZONE

Access to the boxes zones shall be restricted to the persons indicated for the teams

2. SURVEILLANCE IN BOX ZONE

At least one commissioner responsible to the chief commissioner for the boxes, should be present in the box zone or available in their surrounding area 24 hours a day during the whole of the competition. This commissioner may be assisted by security operatives, who should repeatedly patrol the zone at different times for the purpose of discouraging any unlawful practice or tampering with the horses. The chief commissioner should be immediately informed of any irregularity detected.

Commissioners have the duty to protect the horses' welfare and prevent any unlawful practice.

3. HANDLERS

Handlers who have been certified by the organising committee may accompany the horses during the night. The persons responsible for the horses should ensure that handlers or any other persons authorised to enjoy access to the horses, are aware of the security and surveillance regulations in force for the competition.

4. MOVEMENTS OF HORSES IN THE COMPETITION AREA

Movements of the horses between the boxes, warming-up areas, walking areas and competition arena shall be strictly controlled by the chief commissioner and his/her assistants.

5. SURVEILLANCE OF WARMING-UP AREA

The warming-up area shall be kept under permanent surveillance during opening times (from 08.00 up until the end of the last trial of the day). There will also be random control in the period in which the warming-up area is officially closed.
