THE FEI CODE OF CONDUCT

FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. **The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**

Competitors – The Championship is confined to competitors from the year in which they reach their 18th birthday.

Only competitors and horses qualified for the Championship may be entered to participate in the competitions of the Championship.

Each nation must declare whether they intend to participate with a team or with individual competitors.

Nominated Entries: Wednesday 03.07.2013

Each NF may enter a maximum of 10 competitors and 20 horses. Each NF must return to the FEI by 3 July one certificate of capability with all nominated Championship athletes and horses included duly signed by the NF.

The name and address of the team veterinarian must be included with the nominated entries.

Definite Entries: Wednesday 17.07.2013

Each NF may enter a maximum of 5 competitors and 10 horses or up to 2 individual competitors with two horses each. All competitors and horses must be chosen from the list of nominated entries. Due to the very limited amount of hotel rooms in Herning, within a distance of 50 km of the show ground, the OC requests that all those eligible to receive accreditation from each NF are entered in the HippoBase entry system. This includes NF athletes, grooms, NF Presidents, Secretary Generals, Owners, partners of

competitors, children, additional accreditations etc.

Those entered **into the Hippobase entry system** no later than four days after definite entry will be offered a hotel room from the list of hotels.

Substitutions may be made in accordance with article 319.2 as follows:

Athletes and Horses entered for the Championship on the list of nominated entries can be replaced and additions can be made within the limits specified in GRs Art. 116.4.2 until the date of definite entries.

In the event of an accident or illness of an Athlete and/or Horse, substantiated by a certificate from an official recognised doctor and/or veterinarian, between the date of definite entries and one hour before the first Horse Inspection of the Championship, substitutions of Athletes and/or Horses can be made. Such substitutions must be taken from the updated list of nominated entries and require Ground Jury approval.

NFs must execute the CheckIn procedure in HippoBase. The contact supplied during CheckIn will be taken as the official NF contact for any communication on the Championships. For details on HippoBase please see below. The OC and the FEI will regard the data supplied online as the only official entry information. Any information sent to the OC by email or fax, which could also be entered directly into the online system, will not be accepted.

Minimum Eligibility Requirements and Certificates of Capability

In order to be eligible to be included on the list of Nominated Entries, all athletes and horses must have achieved the Minimum Eligibility Requirements and must strictly follow the qualification procedure as published on the FEI Website. The deadline date for achieving the Minimum Eligibility Requirements is:

02.07.2013

Jumping entries must be made via the FEI Online Entry system. Following the completion of the Nominated Entries, National Federations must complete the Certificate of Capability online (1 Certificate per National Federation, to include all Championship Athletes and Horses). Once the Certificate is completed it must be printed, signed by the President of the National Federation and submitted to the FEI Jumping Department (FAO Anna Williams – anna.williams@fei.org). Nominated Entries must be completed and Certificates of Capability must be submitted to the FEI by:

03.07.2013

It is no longer necessary to submit Records of Results for each athlete and horse. This will be automatically generated and confirmed within the FEI Entry System. Please note that it is not necessary for Athletes and Horses to achieve their Minimum Eligibility Requirements as a combination. Following the completion of the Nominated Entries, the FEI will check and approve the eligibility of all nominated Athletes and Horses. Definite Entries can only be made from approved eligible Athletes and Horses on the Nominated Entry list.

CSI3* Horses should not be included on the Certificate of Capability and they do not need

to have met the Minimum Eligibility Requirements. Entries for the CSI3* should still be made via the FEI Online Entry system.

The OC. will provide sufficient sanitary and showering facilities for male and female grooms, with hot and cold water.

The OC will provide sufficient sanitary and showering facilities for male and female grooms, with hot and cold water.

Meals

Lunch and dinner at the expense of OC from 22/8-2013 to 25/8-2013 (both days incl.).

Meals will be served at the show ground in the grooms' lounge.

3. HORSES

Horses will be stabled free of charge in boxes (3m x 3m) on the show ground. The Championship stables will be open from Sunday 18/8-2013 at 08.00 until Monday 26/8-2013 at 10.00.

Bedding each day will be provided by the OC free of charge for horses entered for the Championship– reasonable quantities will be made available. For all other horses the first bedding only is provided by the OC free of charge. Additional supplies will be available at the competitor's expense from the Fodder Store.

Any rider requiring straw should order this in advance through the Hippobase Entry System.

Hard feed and Fodder will be made available free of charge by the OC for all horses entered for the Championship. Additional hard feed and fodder will be available at the competitor's expense.

Electrical supply for live-in-lorries will be made available at a cost of € 80,00 per lorry for the entire event incl. VAT. This must be ordered per vehicle through the HippoBase Entry System.

VERY IMPORTANT: The Organizing Committee will **not** under any circumstances offer additional boxes at the venue for horses that are not taking part in the Championship or CSI3* due to lack of space.

4. TRANSPORTATION

4.1 Local

A shuttle service will be provided by the OC between the Official Championship Hotels accommodating athletes, Chefs d'Equipe, team trainers, team veterinarians and officials and the showground. This transportation service is also available between Herning Railway station and the following airports: Billund and Karup, as well as to and from the showground.

4.2 Chefs d'Equipe, Team Veterinarians, Athletes and Horses belonging to the official Teams and their grooms

The OC will reimburse the costs for travelling Expenses of Chefs d'Equipe, Team Veterinarians, Athletes and Horses belonging to the official Teams and of their grooms to the amount of 200 Euro per team, from the frontier of the host NF's country, or the point of arrival in the host NF's country, to the place of the Event, including the cost of loading on and unloading from a ship or aircraft, of quarantine as well as customs duties in the host NF's country. The same applies for the return journey.

5. WELCOME

The time and date of arrival of athletes and horses and their means of transport must be given to the OC in order to facilitate them upon arrival.

Upon arrival of the horse trucks and/or horse trailers at Herning please follow the road signs.



IX. ADDITIONAL INFORMATION

1. ADVERTISING AND PUBLICITY ON ATHLETES AND HORSES:

The Athletes **are** authorised to carry the logo of their personal sponsor in accordance with Art. 256.3 and 257.3 of the FEI Rules for Jumping. The Chief Steward will check that the advertising and publicity on Athletes and horses complies with these Articles.

2. PRIZE GIVING CEREMONY

The owner of the winning horse **is** invited to the prize giving ceremony for the CSI3* Grand Prix.

The number of athletes required to present themselves for the prize-giving ceremony of each competition is 5. For the medal ceremonies it is either the first three placed individuals or the first three placed teams.

FEI Medals will be awarded to each team member of the three best placed teams in the Team Championship and to the first, second and third placed individuals in the Individual Final.

Athletes are obliged to follow the instructions given by the Director of Ceremony.

3. INSURANCES

All owners and athletes are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

The FEI insures all FEI Officials, whose names are published in the FEI Officials lists, against third party liability including Judges, Course Designers, Technical Delegates, FEI Stewards, FEI Veterinary Delegates, Para Classifiers, Members of the Judges' Supervisory Panel and FEI Coaches (FEI MCP Veterinarians are covered under a different policy):

- **Who are acting for or on behalf of the FEI as stated in the approved schedule of the Event or who are acting in the scope and course of the FEI's Business as described in the final approved schedule; and**
- **Who have received the status of FEI Officials at FEI Events through a qualification process.**

The FEI will NOT insure:

- **National officials officiating at FEI Events; and/or**
- **FEI Officials, who have no official function at the Event.**



The insurance extended is for any liability that the FEI Official incurs to a third party, and for the costs of defending any such claim arising as a result of actions undertaken by the FEI Official in good faith (including errors and omissions) on behalf of the FEI. However, the insurance for obvious reasons does not extend to any liabilities incurred as a result of an FEI Official's dishonest, fraudulent, malicious, and/or illegal act.

Should an FEI Official become aware of an incident that he or she believes might result in a claim, that FEI Official should notify the FEI immediately and provide all of the facts known to the FEI Official. The FEI cannot guarantee the insurance coverage described above in circumstances where the FEI Official has good cause to believe that there might be a claim and does not provide such timely notice directly to the FEI.

2. HEALTH REQUIREMENTS

GENERAL

In accordance with the FEI Code of Conduct it is imperative that all Horses at FEI Events are physically fit and free from infectious disease before being allowed to compete.

ENTRY OF HORSES

- Horses coming from Denmark: No health certificate.
- Horses coming from EU: International Transport Certificate valid between EU members.
- Horses coming from other countries: Valid Certificate, which is required at the moment of import.

3. NATIONAL REQUIREMENTS

None

4. TRANSPORT OF HORSES

Horses must be fit to travel and be transported in vehicles suitable for the transport of horses. Any government requirements for disease testing and control must be requested well in advance, and the Horse be in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have a responsibility to be in compliance of national legislation in both the country of origin, return, and the host nation of the Event; where necessary Athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

**5. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE****PASSPORTS****General Regulations Article 137**

For all Horses FEI Passports/FEI Recognition Cards issues, please address to your National Federation

All Horses competing at FEI Events must be registered with the FEI.

Athletes whose Horse's Passport and/or Recognition Card is not correctly validated, or failing to meet other requirements for vaccination and Equine Anti-Doping and Controlled Medication control (Veterinary Regulations Article 1030) will be **subject to Sanctions in accordance with Annex II of the Veterinary Regulations**.

Athletes will be required to write their name and counter sign next to any passport irregularity entry noted, as an acknowledgement, prior to receiving the passport and leaving the show ground. Following a warning being issued for such an irregularity the Athlete will have 30 days to correct this, failure to correct such irregularities within 30 days will result in a sanction being imposed.

Note for Horses permanently resident in a Member State of the European Union, all Horses must have a national EU passport in compliance with EU Regulations, to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

VACCINATIONS - EQUINE INFLUENZA
2013 Veterinary Regulations Article 1028

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

Exceptions to the requirement for FEI equine influenza vaccinations currently exist only for those Horses competing at CNs or CIMs where there are no national requirements for influenza vaccination in both the Event host country and the Horse's country of origin (General Regulations Article 137).

EXAMINATION ON ARRIVAL

2013 Veterinary Regulations Article 1032

On arrival at an Event venue all Horses must undergo an examination by a veterinarian to confirm their identification from their passport, their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status, with regards to vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

HORSE INSPECTIONS

2013 Veterinary Regulations Article 1033

All Horses will be assessed for their orthopaedic fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit not to compete will be eliminated by the Ground Jury and not be permitted to continue in the competition.

LIMB SENSITIVITY EXAMINATION

All Horses competing at the Event are subject throughout the Period of the Event to Examination under Article 1034 of the Veterinary Regulations, the Limb Sensitivity Protocol. The objectives of the Protocol are to: (i) safeguard the welfare of the horse, according to the principles outlined in the Code of Conduct for the Horse, and (ii) to ensure a level playing field for all Athletes. Horses are not eligible to compete when a limb, or part of a limb, is hyposensitive or hypersensitive. Hypersensitive limbs have an excessive or abnormal reaction to palpation. Hyposensitive limbs include any alteration in sensitivity induced by a neurectomy or chemical desensitisation for as long as the alteration in sensitivity persists.

Horses may be examined under the Protocol at any time during the Period of the Event, including, but not limited to, between rounds and before the Jump Off and they may be examined once or on multiple occasions. All Horses selected to be tested must submit promptly to the Examination or are subject to immediate

Disqualification. There is no obligation to examine any specific number of Horses during the Event.

6. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION **2013 Veterinary Regulations, Chapter VI** **EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP)**

Within FEI Groups I & II, the Organising Committee should charge competitors the equivalent of CHF 12.50 towards the cost of the EADCMP, which is affected by the FEI Veterinary Department.

SAMPLING

All horses competing at FEI Events may be subject to sampling for the presence of FEI Equine Prohibited Substances in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures (2013 Veterinary Regulations Article 1058).

CLEAN SPORT INFORMATION

The current FEI Equine Prohibited Substances List of Banned Substances and Controlled Medications is available on the FEI Clean Sport website: www.FEICleanSport.org as a PDF document, database or smart phone app. Detection times are also provided for a limited number of Controlled Medication substances where available.

Elective Testing may be carried out, by Competitors for their Horses, prior to an Event to check for the presence of prohibited substances (please refer to www.FEI.org/veterinary for information and details).

**7. VETERINARY TREATMENTS, SUPPORTIVE AND OTHER THERAPIES 2013**
Veterinary Regulations Chapter V

Veterinary treatment or supportive therapy required during an Event is under the control of the FEI Veterinary Official (Veterinary Delegate) and only permitted when:

- a) authorised using the appropriate Veterinary Form (see table below, or VRs article 1047-1051), either prior to the competition or prior to administration once the competition has begun;
- b) conducted within the designated Treatment Boxes and
- c) administered by an FEI Veterinarian (VRs article 1003) or Other Treating Professional (VRs article 1021).

Heated or magnetic blankets, physical therapy, ice and cold water, non-prohibited, authorised substances that are administered orally or by nebulisation, or those treatments exceptionally authorised by the Veterinary Delegate are allowed in the Horse's own stable.

Supervision of all such treatments by FEI Officials may take place directly on a random check basis or by requesting to see a copy of the relevant authorisation. No treatments may take place without coming under such control and authority, except in the case of a clear emergency, when a retrospective authority may be considered if the Horse is to continue.



XI. HUMAN ANTI-DOPING

At a minimum, and pursuant to the ADRHAs, Organisers must provide the following at Events where human anti-doping testing is scheduled to take place at least 2 months prior to the Event:

- 1.** One (1) staff member able to act as point of contact and coordinator for the *Doping Control Officers (DCOs)* with the contact name and details of this staff member to be communicated to the *FEI* at least two (2) weeks prior to the starting date of the *Event*.
- 2.** Human anti-doping facilities reasonably separated from public activity, consisting of:
 - one (1) private room exclusively dedicated for use by the *DCOs* with one (1) table, two (2) chairs, pens and paper and one (1) lockable fridge; and
 - a waiting room/area with a suitable number of chairs as well as an appropriate amount of individually sealed, non-caffeinated and non alcoholic beverages, which includes a mix of natural mineral water and soft drinks ; and
 - one (1) private and clean bathroom/toilet, adjacent or as near as possible to the *DCO* room and waiting area.
- 3.** Staff members (or volunteers) of both genders, able to act as *Chaperones*. The number of *Chaperones* available to the *OC* must be communicated to the *FEI* as early as possible following receipt by the *OC* of the *Testing* plan for the *Event*. Please see the qualifications for *Chaperones* in the ADRHAs.

Starting Order:

Individuals - First to start in Round 1st of the Team competition are all individuals. The starting order of individual riders in Round 1 of the Team competition is according to the reverse order of individual classification in the first competition. In case of equality of penalties for any place competitors retain the same starting place as in the first competition.

Teams - Following the first individual competition, teams are divided into two groups based on the results of the best three competitors in each team. The first group of teams to start in the first round of the team competition is that with teams placed eleventh and beyond. The group with teams placed first to tenth and those ex-aequo for tenth place start last. Teams in each group start in the reverse order of classification resulting from the first individual competition. There is a draw to decide the starting order for teams in case of equality of penalties.

Individuals

Round 2 is open to the 50 Athletes (such number to be increased if there is equality for the 50th place) having the best score deriving from the addition of the scores obtained in the First Individual Qualifying Competition and Round 1 of Team Competition (Second Individual Qualification Competition) are allowed to participate in the Third Individual Qualification Competition which is the Round 2 of the Team Competition.

If the Athletes qualified as above are not members of a team which has been qualified to participate in Round 2 of the Team Competition, said Athletes will compete prior to Round 2 of the Team Competition.

Teams

Round 2 of the Team Competition takes place after the Individuals have participated. It is open only to the ten best placed teams and those teams equal on Penalties for tenth place after Round 1 of the Team Competition. Teams that withdraw before the start of Round 2 will not be replaced.

All teams allowed to compete in Round 2 of the Team Competition carry their Penalties forward from the First Individual Qualifying Competition and Round 1 of the Team Competition.

Score obtained in Round 2 by members of Teams who are not among the Athletes eligible to compete in the Third Individual Qualifying Competition as mentioned above, count only for the classification of their respective teams.

Starting Order:

Individuals -The starting order of the individuals qualified to compete in Round 2 is set according to the reverse order of the aggregate penalties incurred in the first individual competition and the first round of the second individual competition. In case of competitors with equality of penalties, the score of the first competition will decide their starting order.

Teams - The starting order of the teams qualified to compete is set according to the reverse order of total penalties of the best three competitors per team incurred in the first individual competition and the best three competitors per team in Round 1 of the team competition. Teams with equality of the penalties retain the starting order of Round 1.

Classification – Team Placing:

The ten teams and those with equality of penalties for tenth place receive their placing by adding the penalties incurred by the best three competitors in each team in the first competition and the penalties incurred by the three best competitors in each of the two rounds of the second competition. The team, which has obtained the least number of penalties will be placed first and declared FEI European Team Champion.

In the event of equality of penalties between teams for first, second and/or third place, there will be a jump-off against the clock in which all team competitors may take part, over six obstacles, which may be increased in height and/or spread at a speed of 400 m/m. The score in this jump-off is obtained by adding the penalties incurred by the three best competitors in the jump-off added together will decide the winning team as well as those placed second or third. The score of this jump-off is only to determine the placing of the teams and will not count towards the final scores of the individual competitors.

If two jump-offs are required, the jump-off for the third place shall precede the jump-off for the first and the second place. If after the jump-off there is equality of penalties and time for one of the first three places, the teams concerned will be placed equal.

Teams not qualified for the second round of the team competition receive their placing by adding the penalties incurred by the three best competitors in each team in the first competition and the penalties incurred by the three competitors in the first round of the team competition.

Eligibility: This third competition is compulsory for the 25 best-placed competitors and horses (including those with equality of penalties for 25th place) according to the cumulative penalties over the first and second competitions or according to the cumulative penalties over first competition and first round of the second competition as well as the rounds replacing the second round of the team competition for individuals and members of teams not qualified for the second round of the team competition. Competitors must have taken part in the first competition (completed or not) and have completed the second competition (without having been eliminated or having retired) or have taken part in the first competition (completed or not) and have completed the first round of the second competition as well as the round replacing the second round of the team competition for individual and members of teams not qualified for the second round of the team competition (without having been eliminated or having retired). If for any reason one or more of these 25 best placed competitors are unable to start, they will be replaced by participants from the reverse list of five competitors.

Starting Order:

Round A -The starting order for Round A will follow the reverse order of penalties incurred in the first and second competitions. For those individuals and members of teams not qualified for the second round of the team competitions the starting order will follow the reverse order of penalties incurred in the first competition and the first round of the second competition as well as the round replacing the second

round of the team competition. In the event of equality of penalties, the score of the first competition will decide the starting order. The 25th qualified will, therefore, start as number one.

Round B - The starting order for Round B will follow the reverse order of total penalties incurred in Round A of the Final competition, as well as in the first and second competitions. For those individuals and members of teams not qualified for the second round of the team competition the starting order will follow the reverse order of total penalties incurred in Round A of the Final competition, the first competition and the first round of the second competition, as well the round replacing the second round of the team competition. The competitor with the most penalties will start first; the competitor with the least penalties will start last. In the event of competitors with equality of penalties, the score of the first competition will decide their starting order.

Classification – Individual Placing:

The individual placing is determined by adding together for each competitor the penalties incurred in the first competition, as well the two rounds of the second competition (disregarding the penalties incurred in the jump-off if there is one) and the two Rounds A and B of the third competition. For those individuals and members of teams not qualified for the second round of the team competition their score in the second round qualifier counts instead of the second round of the team competition.

The competitor with the least penalties will be placed first and declared the FEI European Champion.

In the event of equality for one of the first three placed after Round B of the third competition, there will be a jump-off against the clock at a speed of 400 m. per minute over 8 obstacles from the courses of Rounds A and B. The competitors will be invited to inspect the jump-off course.

If two jump-offs are required, the jump-off for the third place shall precede the jump-off for the first place and the second place.

If after the jump-off there is equality of penalties and time for one of the first three places, competitors concerned will be placed equal.
