
Hotel: at the expense of the O.C. FFE

3. WELCOMING

The day and the hour of arrival of riders and horses, as well as their means of transport used, will have to be specified with the O.C. FFE in order to facilitate their arrival.

At this arrival, the coach must give horses' passports and players' ID cards to the O.C. FFE in order to control entries.

IV. SEVERAL INFORMATION



1. REWARD CEREMONY

All players must **come on horseback** with their coaches to the reward ceremony.

Each must respect O.C. FFE information in order to guarantee everything goes as smoothly as planned.

2. INSURANCES

The O.C. FFE and its commissioners are not responsible for damages done to property, persons and fortune, caused by accidents and malady of athletes, ponies and stable staff. Damages on coaches, harnesses, saddlery, stable utensils and all other objects (including damages of theft, fire) or other incidents are not under responsibility of the O.C. FFE and its commissioners.

All owners and athletes are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. It is thus strongly recommended to any rider or owner to hold their own insurance (RC) with a cover sufficient for the contests as well abroad as in its country, and to maintain this policy in force.
