# FEI WORLD DRIVING CHAMPIONSHIPS 2014 SINGLES

## QUALIFICATION CRITERIA

**Izsak (HUN)**  
**24-28.09.2014**  
Updated 20.02.2014

**1. Qualification period**

Start: 1 January 2013  
End: TBC - (nominated entries date)

**2. Qualification criteria**

To be applied in conjunction with Art. 913 and 914.1-6 of the FEI Driving Rules.

**Drivers:**

Open to athletes having reached the level of 3\* and who meet the following criteria:

At two (2) combined driving events, Drivers must achieve a score of 65 points or less in the Dressage test (test 9) and have successfully completed (without Elimination, Disqualification or Retirement) all three competitions (Dressage, Cones, Marathon) in their own class.

One of the qualifying result as defined above must be achieved no earlier than on the 1<sup>st</sup> January of the year in which the Championships take place and no later than the end date of the qualification period.

---

Maximum Driven penalty points allowed at the Championships in Dressage as per Art 914.4: 70 points

Dressage test 9 will be run at the Championships.

## REMINDER

**REMINDER: All Riders & Horses participating in any International competition must be registered with the FEI.**

See General Regulations, 23<sup>rd</sup> Edition Art. 113.3:

**"Any Athlete and/or any Horse who is not registered with the FEI shall be automatically disqualified".**
