V. INVITATIONS

CH-EU-D YH:

Foreign athletes are invited by the Organising Committee through their NF.
One groom per athlete.

1. The World Breeding Championship for Young Horses in Dressage will be organised under FEI Rules with the support of the World Breeding Federation for Sport Horses. The selection procedure will be decided by the relevant National Federations in cooperation with the breeding organisation(s) in their country. The horses must have shown results of at least 65% in a selection procedure in appropriate Young Horse Classes at national level. Horses are only allowed to take part in a selection procedure of one country and not more.
2. a) The general principle is that only NFs may nominate horses if there is a WBFSH member studbook within the country of that respective NF.
b) An exception to the rule 2.a) can be made for NFs, if
 - the athlete is an athlete with the nationality of that respective NF and
 - the horse is a horse of a WBFSH member studbook and owned by a person of the respective NFs country and
 - the (origin)studbook of the horse and the NF of that respective country, where the horse/athlete-combination is training, support the nomination.
3. a) The general principle is that NFs will enter horses that have a pedigree of a national studbook, which is a member of the WBFSH and whose seat is within the field of activity inside the respective NF.
b) An exception to the rule that horses have a pedigree of a studbook which is a member of the WBFSH and whose seat is within the field of activity inside the respective NF, will be made in 2011.
4. The number of horses which may be entered by NFs in each class (i.e. five and six year old) is as follows:
 - Germany 7
 - The Netherlands 6
 - Denmark 4
 - Sweden 4

All other accredited NFs may enter up to two horses in each class, if there is a WBFSH member studbook within the country of that respective NF. All other accredited NFs may enter one horse in each class.

Horses born in the Southern Hemisphere, that are 7 years old will be permitted to take part in classes for 6 year old horses and horses born in the Southern Hemisphere, that are 6 years old will be permitted to take part in classes for 5 year old horses, provided they are born between 1st August and 31st December).

5. As an exception to the FEI General Regulations, NFs may enter athletes of a different nationality provided the athlete's NF will give its approval. The combination of this exception with exception number 3 b) is not allowed.
6. Wildcards:
 - NFs may apply for wildcards only for horses that are registered in member studbooks of the territory of the respective NF and are trained abroad. These horses must have shown results of at least 75% in a selection procedure in accordance with 1.
 - Exceptions to this rule will be considered for 2011 only for horses with a pedigree (showing at least three full generations) of a studbook, which has not been a member of the WBFSH and whose field of activity does not extend over a country in which already a WBFSH member exists. The exception will be made only once.

- The number of wildcards depends on the total number of horses entered - a max. number of 50 horses per age group will be admitted.
 - Wildcards will be decided by the WBFSH and the FEI in close cooperation with the OC's NF and the OC.
 - Wildcards will be assigned in the following proportions: GER max 3, NED max 2, and all other NFs max 1.
 - Only wildcard requests from NFs will be considered; requests received from individuals will directly be refused.
 - Wildcards will apply to specific horses only and will not be subject to substitution by NFs.
 - Only the OC in close cooperation with the OC's NF and the FEI may allow substitutions.
 - Wildcards cannot be assigned to horses that have taken part in national selection systems, unless the respective NF agrees.
 - The final decision regarding wildcards and substitutions will be decided by the WBFSH and the FEI. No further appeal against this decision will be allowed.
7. In the Final competition of each class, no NF may have more horses than the number of places originally allocated excluding wildcards (i.e. GER 7, NED 6, DEN 4, SWE 4, other NFs 2).
8. Each athlete may start a maximum of two horses in each class including the Final competition in each age group.
9. The above-mentioned athletes are invited to compete in the national competitions (28 and 29). According to the regulations pertaining para 20.5 LPO (German Show Rules), in the national competitions 15 athletes from four guest nations are admitted.

 - Athletes must have an "Amateur Owner's" license of their respective NF, such a licence will only be granted by NFs to those Athletes who have formally signed a statement that he/she does not earn money for riding other people's horses, giving riding lessons, or for publicity or commercial purposes, etc.
 - An Amateur Owner licence will only be granted by NFs to those Athletes who have formally signed a statement that he/she does not earn money for riding other people's horses, giving riding lessons, or for publicity or commercial purposes, etc.
 - The buying and selling of horses, as well as receiving prize money in cash, are not forbidden providing they do not constitute the competitor's mainly source of income.
 - Athletes participating in the CSI Amateurs may not start in any other international competition of the event.
 - Holding the "Amateur Owner" status, athletes are not barred from other competitions or Championships. As long as the athlete holds the „Amateur Owner“ status, he/she will not be allowed to take part in international or national initial competitions with a height of 1.50 m or greater.

Customs' and veterinary fees will not be taken over. For customs and veterinary formalities for horses from abroad, the OC charges € 30,00 per horse.

2. HEALTH REQUIREMENTS FOR THE ENTRY OF HORSES

Every athlete is supplied to deliver all necessary certificates of health for the transport to the event or identification of the horses before they come into the stables:

- a) in case of arrival from a EU-member-country, a certificate for registered horses acc. to sample of Annex B to Regulations 90/426 of the actual valid form will be necessary.
- b) in case of arrival from a country not concerning to the EU, a certificate of health for registered horses acc. to sample of annex II of the decision of the commission 92/260 of the actual valid form will be necessary.

A certificate must be done in at least one official language of the country of destination and in one official language of the member country. The athlete must carry with him the original certificate, not a copy.

The organiser sees to it that on the competition site, an official state veterinarian is present to issue the health certificates which are necessary for the transport of the horses to their destination abroad.

In case the OC has entrusted to a forwarding agency, the latter is ready to assist regarding the required documents.

Furthermore, questions relating to health requirements for horses can be directed to the veterinary authorities in the country of origin or in Germany.

VETERINARY REGULATIONS, 12th edition, effective 5th April 2010, updates effective 1st January 2011

VETERINARY EXAMINATIONS, HORSE INSPECTIONS & PASSPORT CONTROLS

These will be carried out in accordance with the "Veterinary Regulations", Art. 1011 & the discipline rules.

"General Regulations", 23rd edition, effective 1st January 2009, updates effective 1st January 2011:

PASSPORTS (ART. 137)

1. Every Horse entered for any Competition at CNs or CIMs (see Appendix E) and in CSI-P and CSI-Ch-A in a country other than the country of the Horse's nationality, and all Horses entered for other CIs, CIOs, FEI Championships, Regional, Olympic Games and Paralympic Games, whether at home or away from the country of its nationality (see Article 139.2), must have an official, valid FEI passport, or a national passport approved by the FEI and accompanied by an FEI Recognition Card and, when applicable, must be registered with the FEI, as a means of identification and to establish ownership.

2. Horses taking part in CNs and CIMs (see Appendix E) and in CSI-P and CSI-Ch-A in their country of nationality are not required to have such a passport as is mentioned in paragraph 1. All such Horses must be properly registered with the FEI and identifiable and, unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin all Horses must have a valid vaccination certificate.

EQUINE INFLUENZA VACCINATION, VET. REGS. ANNEX VI

(except events taking place in NZL & AUS)

From 1 January 2005 onwards, influenza vaccination for all horses competing in FEI competitions requires a vaccination within six months + 21 days of the competition.

1. All horses intending to participate in FEI competition must have at least received an initial primary course of two vaccinations, given between 21 and 92 days apart. Thereafter, a third dose (referred to as the first booster) must be given within 7 months after the date of administration of the second primary dose, with at least annual boosters given subsequently (i.e. within one year of the last dose).

2. If the horse is scheduled to take part in an FEI competition, the last booster must have been given within 6 months + 21 days of arrival at the FEI event. (The 21-day window has been provided to enable vaccination requirements to fit in with the competition schedule).

3. No vaccination shall be given within 7 days of the day of arrival at the FEI event.

4. All horses that were certified as correctly vaccinated under the previous FEI equine influenza vaccination rule prior to 1st January 2005, do not need to start a primary course again provided that they have complied with the previous rule of primary course and annual re-vaccinations and the new rule of a booster vaccination within 6 months + 21 days of the day of arrival at the FEI event.

SAMPLING FOR PROHIBITED SUBSTANCES (Vet. Regs. Art. 1016.4)

Regular sampling is carried out in CCI3*/4*, CSIs (3*, 4*, 5*), CIOs, World Cup Qualifiers and Finals, Championships and Games, whereas at other CIs sampling is recommended. When testing takes place, the number of horses tested is at the discretion of the Testing Veterinarian/Veterinary Delegate. At CCI3* and CCI4*, CSIs (3*, 4*, 5*), CIOs, World Cup Qualifiers and Cup Finals, Championships and Games it is recommended that a minimum of 5% of all horses (with a minimum of 3 horses tested) must be sampled (see also VR Art. 1016.5.).

Special guidelines are applicable for events covered by the FEI Medication Control Programme (Groups I & II only).

MEDICATION CONTROL PROGRAMME (GROUP I & II ONLY)

The Organising Committees of FEI events within Groups I & II are advised to charge Athletes the equivalent of CHF 12.50 per horse per event as a contribution towards the costs of the MCP programme.

X. MISCELLANEOUS

1. PROTESTS

All protests to be valid must be made in writing and accompanied by a deposit of CHF 150.- or equivalent.

2. PRIZE-GIVING CEREMONY/HONOUR OF MEDAL WINNERS CH-M-D YH)

The owner of the winning horse is invited to the prize giving ceremony for the Grand Prix of the CSI2* (comp. 14).

The OC reserves the right, to hold single prize-giving ceremonies of medal winners of CH-M-D YH (in addition to the normal prize-giving ceremonies) in other competitions arenas of the show grounds. The Athletes are obliged to attend them.

3. PRIZE - CLASSIFICATION

FEI Medals to the athletes placed 1st to 3rd in the respective final competition of the CH-M-D YH. WBFSH-Trophy to the winner. Special prize to the most successful breeding organisation of the CH-M-D YH.

4. DEDUCTIONS FROM PRIZE MONEY

All prize money and all prizes in kind rewarded instead of prize money as well as reimbursements (e. g. transport charges, travelling expenses) will be distributed acc. to FEI-RG Art. 127/128 following the last competition at the latest. The scheduled prizes are gross amounts.

Settlement will be done per athlete. Depending on the agreement with the horse owner, each athlete binds himself to pass on to the horse owners the prize money or prizes in kind rewarded instead of prize money. The organizer is allowed to deduct possibly outstanding debts of the athlete.

Acc. to § 50a EstG this also applies to foreign horse owners. After having deducted the VAT from the prize money or prizes in kind rewarded instead of prize money, as a rule the following income tax will be due: no taxes up to 250 EUR, 15 % exceeding 250 EUR (in force as of 01.01.2009); plus solidarity fee (at present 5.5 %) of the income amount. Travelling expenses being taken over or reimbursed are only regarded as revenues if they exceed the actual costs and the reimbursement for additional meal allowances acc. to § 4 Abs. 5 Satz 1 Nr. 5 EstG. The tax deduction has to be certified on demand. Those foreign athletes being exempted from tax deduction are kindly asked to submit an exemption certificate either with the entry or on the first show day at the latest. Every athlete himself is responsible for the correctness of the details he submits.

5. INSURANCES

All owners and athletes are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

6. LIABILITY

The organizer declines any liability for property or pecuniary damage which may happen to visitors, athletes, grooms and horse owners through slight negligence of the organizer, his delegates or his assistants. The OC is liable in case of intent, gross negligence as well as in case of injury to life, body or health and in further cases he is liable for compelling legal liability acc. to the legal requirements. Furthermore he also declines any liability for theft or other incidents.

7. EVENT'S ORGANISATION

In exceptional circumstances, together with the approval of the Delegate of the NF GER, the Foreign Technical Delegate and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and must be reported to the FEI Jumping Department by the Foreign Judge Jumping or to the FEI Dressage Department by the Foreign Technical Delegate Dressage.

8. ENTRY RIGHT TO SHOWGROUNDS

Entry rights will be handed out to two owners per horse (acc. to FEI passport) for each athlete with one accompanying person, for one groom per athlete. Entry right to the stable area in acc. with VR Art. 1005.2.5.

9. SCHOOLING DURING COMPETITIONS

Athletes wishing to school during speed competitions (Table A and Table C) must inform the OC before these competitions begin. These athletes will start first in these competitions.

THE FEI CODE OF CONDUCT

FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
