**Jumping**

- A) Athletes and Horses that participated in the 2012 FEI European Championship for Young Riders and Juniors in their respective age category are qualified to compete.
- B) Athletes (of the appropriate age) and Horses that have completed the first round of a Grand Prix competition at any 2012 or 2013 European CSI1\*/CSI2\* outdoor event or CSIO1\*/CSIO2\* outdoor event with a score of not more than eight penalties are qualified to compete.
- C) Athletes (of the appropriate age) and Horses that have completed the first round of a Grand Prix competition at any 2012 or 2013 European CSI3\*, CSI4\* or CSI5\* outdoor event or the first round of a Nations Cup or Grand Prix competition at any CSIO3\*, CSIO4\* or CSIO5\* event with a score of not more than eight penalties are qualified to compete.
- D) Athletes and Horses that have completed the first round of a Grand Prix competition in their own Category at a 2012 or 2013 CSII/CSIJ outdoor event with a score of not more than eight penalties are qualified to compete.
- E) Athletes and Horses that have completed the first or second round of a Nations Cup competition in their own category at any 2012 or 2013 CSIOY/CSIOJ outdoor event with a score of not more than eight penalties, or that have completed the first round of the Grand Prix competition in their own category with a score of not more than eight penalties, are qualified to compete.
- F) In addition, Athletes or Horses that have completed the first round with no more than eight penalties at either:
- a. Competition No: 31 – 24.02.2013 (Junior Qualification)
  - b. Competition No: 67 – 03.03.2013 (Junior Qualification)
  - c. Competition No: 103 – 10.03.2013 (Junior Qualification)
  - d. Competition No: 139 – 17.03.2013 (Junior Qualification)
  - e. Competition No: 172 – 24.03.2013 (Junior Qualification)
  - f. Competition No: 62 – 02.03.2013 (Young Rider Qualification)
  - g. Competition No: 98 – 08.03.2013 (Young Rider Qualification)
  - h. Competition No: 134 – 16.03.2013 (Young Rider Qualification)
  - i. Competition No: 176 – 23.03.2013 (Young Rider Qualification)
- at the CSI Vejer de la Frontera Tour (ESP) are qualified to compete.
- G) In addition, Competition 10 at the CSI1\* Istanbul (TUR) on 04.05.2013 will act as a qualifier for Junior athletes who complete the first round of the competition with no more than eight penalties.
- H) In addition, the following competitions at the CSN Barnadown (IRL) will act as a qualifier for athletes who complete the first round of the competition with no more than eight penalties:
- a. Competition No: 12 – 06.04.2013 (Junior Qualification)
  - b. Competition No: 13 – 06.04.2013 (Young Rider Qualification)
- I) In addition, the following competitions at the CSN events in Athens (GRE) will act as a qualifier for athletes who complete the first round of the competition with no more than eight penalties:

- a. Competition No: 8 – 07.04.2013 (Junior Qualification)
  - b. Competition No: 11 – 07.04.2013 (Young Rider Qualification)
  - c. Competition No: 8 - 17.05.2013 (Junior Qualification)
  - d. Competition No: 11 – 17.05.2013 (Young Rider Qualification)
- J) In addition, the following competitions at the CSI2\* Chepstow (GBR) 03-05.05.2013 will act as a qualifier for athletes who complete the first round of the competition with no more than eight penalties:
- a. Competition No: 11 – 03.05.2013 (Junior Qualification)
  - b. CSN Junior Grand Prix (Junior Qualification)
  - c. CSN Young Rider Grand Prix (Young Rider Qualification)

**Timeline for athletes and horses to achieve the FEI minimum eligibility criteria is from the 1<sup>st</sup> January 2012 through to the 16<sup>th</sup> June 2013, Certificates of Capability to be submitted to the FEI by 17<sup>th</sup> June 2013.**
